Julia is fully trained as a civil rights investigator and Title IX Coordinator, and regularly conducts investigations of alleged sexual harassment and sexual misconduct, including sexual assault.

Her investigations commence with analysis of the allegations to develop an investigation plan in consultation with the Title IX Coordinator and, if applicable, a co-investigator. She prepares interview summaries and investigative reports in keeping with each institution's format and style. Julia advises all individuals with whom she meets about available resources and supports, the institution's policy against retaliation, and makes connections with and draws upon the institution's support resources as called for in each case.

Julia identifies as a member of the LGBTQ community and has sustained significant community involvement around LGBTQ issues and awareness, which imbues her investigation skills with a thorough understanding of and innate facility with matters involving LGBTQ students and issues.

Julia helps institutions review and revise their policies to ensure compliance with the most up-to-date federal and state guidance related to Title IX/sexual misconduct on campus. She trains administrators, faculty, staff, and campus safety departments on institutional policy and conducting trauma-informed sexual misconduct investigations, hearings and appeals. Julia closely analyzes federal and state guidance regarding Title IX and Enough is Enough and interacts with issuing authorities regarding published guidance.
